Coalition Launches New Americorps Program in Shelters Across the State!



Housing. What's Next As Affordable Housing Rules Take <u>Effect?</u>

At the 2024 New Jersey Governor's Conference on Housing, policymakers emphasized expanding multi-family housing and sustainable development but gave limited attention to addressing segregation. Meanwhile, affordable housing in the state is set to undergo major changes in 2025 as municipalities must meet new obligations under the Mount Laurel Doctrine, although legal challenges could delay these efforts. Housing experts warn that New Jersey faces a shortage of over 200,000 affordable units, affecting at least 25% of renters. vtdigger

Adenah Bayoh, a Liberian immigrant and entrepreneur, is set to become the first Black woman to spearhead a major affordable housing project in New Jersey. Her 40-unit development in Newark's South Side focuses on creating opportunities, with amenities like free Wi-Fi, computers for residents, and transitional housing for families experiencing homelessness. Bayoh's journey from war-torn Liberia to leading community-focused real estate initiatives highlights her commitment to transformative housing solutions that address generational challenges in underserved communities



Baraka Shares Plan To Tackle Housing Crisis If Elected NJ Governor Patch

New Jersey is facing a shortage of nearly 200,000 housing units, a gap that Newark Mayor Ras Baraka aims to address with his housing reimagined policy if elected governor in 2025. Baraka's plan includes creating an affordable housing task force, allocating half of the state's tax credits for affordable housing, establishing a First Loss Capital Fund to support highimpact projects, and capping rent increases at cost-of-living adjustments for two years. Baraka emphasizes that solving the housing crisis requires a regional, collaborative approach to address the root causes.



Op-Ed: McGreevey's Affordable Housing Plan Doesn't Add Up Jersey City Times

McGreevey's claims about building 1,000 affordable housing units with diverted PILOT funds and other sources lack credibility when examined closely. While optimism is nice, the Pompidou PILOT can't be undone easily, and even if it were, those funds wouldn't directly finance affordable housing. His misleading numbers on funding sources like LIHTC, ASPIRE, and the Affordable Housing Trust Fund demonstrate a lack understanding or transparency. of Jersey City needs real policy solutions, not promises that can't be delivered.

Building In Newark Earns 'Smart Growth Award' FromNJ Future

The mixed-use development at 20 Littleton Avenue in Newark, featuring 78 affordable housing units and ground-floor healthcare services, has received a prestigious "Smart Growth Award" from New Jersey Future. The project, recognized for its commitment to sustainability and inclusivity, is a collaboration between local partners, including the City of Newark and University Hospital.





Toms River Plans 17-Bed Homeless Shelter Jersey Shore Online

The Christ Church of Toms River has been hosting a homelessness outreach program since July 2023, offering services like housing referrals and showers. Plans are now underway to expand the church's support by creating a 17-bed homeless shelter, managed by the Affordable Housing Alliance (AHA). The proposed shelter, which requires a zoning variance, would offer temporary housing and services for people in need, but has raised concerns from local residents about its impact on the neighborhood.



<u>12 More Towns Sue State</u> <u>Over New Affordable Housing</u> <u>Law</u> nj.com

A coalition of 21 municipalities in New Jersey, led by Montvale Mayor Mike Ghassali, has filed an amended lawsuit against the state, claiming that a new law aimed at increasing affordable housing is an overreach. The law standardizes municipal obligations for affordable housing and provides protections against lawsuits opposing such developments. The plaintiffs argue that the law exceeds constitutional requirements under the Mount Laurel Doctrine and question the exemption of certain municipalities, while state officials defend the law as essential for addressing housing needs in New Jersey.



New \$6 Million Center Providing Social Services For Homeless Population Planned In Camden

Camden County plans to establish a \$6 million Multi-Agency Center (MAC) in the Bergen Square area to provide comprehensive social services for the homeless population, rather than functioning as a traditional homeless shelter. The center will offer various services, including assistance with identification, cashing social security checks, and amenities like washers, dryers, and showers, aiming to help individuals transition into permanent housing. With an estimated 148 unsheltered individuals in Camden County, the MAC seeks to reduce this number significantly by addressing the obstacles that keep people from finding stable housing.

NJ Town First To Agree To 1500 Plus New Affordable Housing Units Over Next Decade

South Brunswick Township has reached a significant settlement with the Fair Share Housing Center, allowing for the development of over 1,500 new affordable housing units over the next decade. This agreement comes after a lengthy legal battle regarding the township's compliance with state-mandated affordable housing obligations, shifting from previous resistance to embracing a variety of projects, including larger apartment complexes. With plans to meet its housing goals ahead of new state requirements, South Brunswick aims to address the affordable housing crisis while collaborating with housing advocates.

Homeless With Sleeping Ban

Millville has recently passed an ordinance prohibiting individuals from sleeping in public spaces, such as streets and sidewalks, as part of an effort to address rising homelessness in the area. The new law imposes a \$500 fine for a first offense, with subsequent violations potentially resulting in fines up to \$2,000 or jail time. This move has drawn criticism from advocates who argue that such measures further stigmatize and penalize those experiencing homelessness rather than providing effective solutions.

<u>Can NJ Get Creative To Build</u> <u>More Affordable Housing?</u>

New Jersey faces a long-standing housing crisis, requiring an estimated 214,000 additional lowrent homes to meet demand. Despite nearly 50 years of state Supreme Court rulings aimed at increasing affordable housing through the Mount Laurel Doctrine, only 72,000 units have been added since its inception. Recent strategies from California's proactive housing policies, including the YIMBY movement and innovative zoning reforms, offer potential solutions for New Jersey to overcome local resistance and significantly boost affordable housing availability. With new laws set to enhance state oversight and compliance, the time is ripe for New Jersey to adopt successful models from other states and tackle its housing challenges head-on.

NEWS FROM AROUND THE COUNTRY

Florida Enacts Tough Law To Get Homeless Off The Streets, Leaving Cities And Counties Scrambling

Florida has enacted one of the nation's strictest anti-homelessness laws, making it illegal to sleep in public spaces such as sidewalks, parks, and beaches. With an estimated 31,000 homeless individuals in the state, local officials



are now racing against the clock to develop adequate shelter solutions or risk lawsuits for failing to comply. While some cities are exploring temporary encampments and converting abandoned buildings into shelters, advocates express concern that this law may further isolate vulnerable populations, complicating their access to essential services and support.

SF Frontline Workers Who Help People On Streets, In Shelters Call For Fair Pay KQED Frontline workers in San Francisco, like Brenna Alexander, a clinical social worker at UCSF, are advocating for fair pay due to significant salary disparities compared to their colleagues at medical centers, despite having similar qualifications. Many campus social workers face daily safety risks while providing essential services to vulnerable populations, yet they earn about one-third less



than their peers, contributing to high turnover and burnout. The union representing these workers is pushing for equitable compensation and better career advancement opportunities to ensure adequate staffing and support for individuals experiencing homelessness and mental health crises in the city.



Hundreds Of Thousands Of Housing Units Could Lose Affordability Planetzen

As the 30-year term of the Low-Income Housing Tax Credit (LIHTC) expires, hundreds of thousands of affordable housing units could see rent hikes or evictions, affecting low-income families who rely on this housing. By 2030, 350,000 units may lose affordability, rising to 1 million by 2040. While some states like California have extended affordability requirements, most have not, leaving many units at risk.

One Possible Housing Crisis Solution? A New Kind Of Public Housing For All Income Levels NJPR

A new approach to addressing the housing crisis is emerging with mixedincome public housing, where local



governments fund and own housing projects for residents across all income levels. This model, which ensures long-term affordability by reinvesting market-rate rents into lower-income units, is gaining attention for its potential to create inclusive, high-quality housing without relying heavily on federal funding. Examples like Montgomery County, Maryland's Hillandale Gateway project are leading the way, offering a sustainable solution to the growing housing shortage.

Yes, There's A Solution To Unsheltered Homelessness In California. It's

Called Interim Housing.

Hillview Healthcare Center in La Crosse, Wisconsin, is undergoing a \$19.6 million renovation to transform its underutilized space into a multi-use facility that will support various community needs. The project will create a more comfortable living area for nursing home residents, establish a multi-generational day care center, and provide ten short-stay units for individuals experiencing homelessness, in collaboration with the city's Pathways Home program. This innovative approach not only addresses local gaps in services but also aims to alleviate staffing shortages in the nursing home by offering childcare solutions for its employees.



California Homeless Crisis: Several Bay Area Cities, Counties Receiving State Money To Combat Homelessness abc7news.com

California Governor Gavin Newsom announced over \$130 million in funding to help combat homelessness, with several Bay Area cities and counties, including San Francisco and Contra Costa County, receiving a share of the grants. Contra Costa County plans to use its \$5.7 million allocation to clear an encampment near San Pablo, providing permanent housing and supportive services for those affected. While the funding is a crucial step toward addressing homelessness, advocates stress the importance of ensuring the money reaches those most in need and highlights the ongoing challenges of addressing the root causes of homelessness.



Thousands March In Spain To Demand Affordable Housing Reuters

On October 13, thousands of Spaniards took to the streets of Madrid to demand affordable housing, rallying under the slogan "Housing is a right, not a business." As living costs soar and residents feel pushed out of their cities, protesters called for government regulation of rental prices and improved living conditions. Similar demonstrations occurred in Barcelona and tourist-heavy regions, where seasonal workers face housing shortages, often resorting to living in caravans or cars due to skyrocketing rental costs.



COMMENTARY: Removing Barriers To Abundant, Affordable Housing RJESPAÑOL

The U.S. is grappling with a housing affordability crisis largely due to local governments imposing restrictive land use and zoning regulations that limit housing supply. Nearly half of American renters are costburdened, with many spending over 30% of their income on housing, yet construction rates have plummeted since the 2008 housing crash. To address this issue, local governments must reform these outdated regulations to encourage the development of diverse housing options, and the federal government can play a crucial role by incentivizing communities to adopt more inclusive zoning practices.
