Call Your Members of Congress Today to Urge Them to Protect Medicaid from Harmful Cuts!

Call (202) 224-3121 NOW to urge your representatives to oppose any cuts to Medicaid!

Please call your congressional representatives, using this action from the Legal Action Center, to urge them to protect Medicaid from harmful cuts and restrictive conditions. Among the options being discussed are work requirements for enrollees (despite the fact that most people receiving Medicaid do work) and other cuts to federal funding.

Sample call script:

I am a constituent from Senator/Representative ____'s state/District calling to urge them to protect Medicaid. Cuts to this program would cause millions of Americans nationwide to lose vital health care coverage and would be especially harmful to people in need of substance use and mental health care. I strongly urge the Senator/Member to protect this lifeline and oppose cuts or harmful policy changes that would threaten people's ability to access lifesaving care.

Be sure to share your personal story, letting them know why Medicaid matters to you, your loved ones, your community members, and the millions of Americans whose futures hang in the balance.

<u>Paterson Moves Ahead With Ordinance</u> To Penalize Homeless Encampments

The city of Paterson is moving forward with an ordinance that would ban camping or sleeping in public spaces, imposing fines up to \$2,000 and jail



sentences of up to 90 days. Mayor Andre Sayegh argues this measure addresses sidewalk obstructions and community complaints while offering support through various programs. Critics, however, argue that such punitive actions criminalize homelessness, create barriers to housing, and fail to address the underlying issue of affordable housing shortages. The ordinance is scheduled for a final vote on Jan. 21.

With Homelessness Rising, New Eviction Protection May Help

Senior citizens and people with physical and mental disabilities may soon have greater legal protections to prevent forced evictions if their rental housing is converted to a condominium or a cooperative. A bill pending before state lawmakers aims to extend the protected tenancy period for these renters from 40 years to their full lifetimes. Eviction is now among the leading causes of homelessness in the state in recent



years, increasing significantly from 14.1% in 2022 to 18.51% in 2023, according to a report from the state Office of Homelessness Prevention. Coalition Executive Director, Connie Mercer, is quoted, noting "The New Jersey Coalition to End Homelessness applauds the intent to preserve the dignity and safety of our elderly and handicapped with this bill."



Here's What's Driving the Surge in Homelessness: An Interview with Michael Callahan

Last week the U.S. Department of Housing and Urban Development's annual homelessness assessment report found more than 770,000 people experiencing homelessness across the country on a single night in January last year. That is an 18% increase from the 2023 assessment.

In New Jersey, the point-in-time count from January 2024 saw an even higher increase 24% over the prior year. NJ Spotlight sat down with NJ's Director of the Office of Homelessness Prevention, who explained that "one of the main precipitating causes of homelessness, it's not what people would generally associate with homelessness being either mental health challenges or substance use. In fact, it's evictions and being asked to leave a shared residence."



Atlantic City Launches New Effort



Answering Demand In Camden,
Overnight Homeless Shelter

To End Unsheltered Homelessness

The New Jersey Department of Community Affairs (DCA) launched a three-year initiative aimed at addressing unsheltered homelessness in Atlantic City. The initiative focuses on collaboration between the city, nonprofits, and healthcare providers, with a strategy to improve outreach, shelter access, prevention services, and housing options. The program will also implement real-time data tracking to better target outreach efforts and create citywide care standards, while focusing on specific populations such as seasonal workers, veterans, and individuals with health conditions.

TAP into Camden

Joseph's House, a homeless shelter in Camden, is transitioning to a 24/7 operation to better support individuals who have nowhere else to go during the day after its nightly closure. The shelter serves individuals with complex needs, including those battling addiction, mental illness, or chronic homelessness, and aims to expand its services to help them stabilize. While the initiative is welcomed, the shelter faces challenges related to funding and resources, emphasizing the need for community support to sustain its expanded hours and services.



Affordable Housising Is The Key To New Jersey's Future

New Jersey's severe affordable housing shortage disproportionately affects Latino families, exacerbating racial and social inequities. The Mount Laurel Doctrine, a policy that requires municipalities to provide a fair share of affordable housing, has been a key solution, with recent legal changes streamlining the process and promoting inclusive development. These efforts offer transformative opportunities for families, improving education, health, and economic outcomes, and benefiting entire communities by fostering economic growth and social cohesion.



Judge Rejects 26 NJ Towns' Attempt To Stop Affordable Housing Law From Moving Forward

A New Jersey judge denied 26 towns' request to pause the state's affordable housing process while their lawsuit challenging new requirements is ongoing. Judge Robert Lougy ruled that the public interest in creating affordable housing outweighs the towns' claims of being overburdened, emphasizing the need for equitable housing solutions. The towns plan to appeal, while state officials and housing advocates commend the decision as a step toward meeting the state's housing needs under the Mount Laurel doctrine.

Mental Health Needs For NJ Homeless Population

The mental health needs of New Jersey's homeless population, particularly children, are rising as housing instability takes a toll on emotional well-being. At a hearing in Princeton, advocates urged the state to expand mental health services to better support those facing homelessness, highlighting the growing urgency of this issue.



New Jersey Towns Face Key Affordable Housing Deadline This Month

New Jersey municipalities face a January 31 deadline to either accept or challenge their assigned affordable housing obligations under a new law aiming to build over 84,000 homes



and rehabilitate 65,000 units by 2035. While some towns embrace the state's targets, others are suing, arguing the requirements strain infrastructure and lack feasibility. Despite ongoing litigation, all municipalities must prepare plans to meet their obligations by June 30, navigating a contentious and complex process.

Over its 40-year history, the program has expanded across 11 New Jersey counties, diversified its funding sources, and continues to address the increasing economic challenges of its clients. By fostering community-driven solutions, HomeSharing transforms lives, as shown in success stories like Susan's, where a simple housing match brought financial stability and emotional peace to both parties.

VA Announces Plan To Award Hundreds Of Millions In Grants, Launches New Innitiative To Help

US Interagency Council On Homelessness

The Department of Veterans Affairs (VA) announced three key initiatives to assist Veterans experiencing homelessness, including awarding funding for supportive services and



case management grants, and launching the Mayor's Pledge to House Homeless Veterans. The VA will distribute millions of dollars in grants to support rapid rehousing, prevent homelessness, and fund case management for existing programs. The Mayor's Pledge aims to engage mayors and local landlords to help provide permanent housing solutions for Veterans, a critical component in the VA's effort to reduce Veteran homelessness, which has decreased significantly since 2010.

HUD Highlights Significant Accomplishments In Rental Assistance Programs, Strengthening Housing HUD

A new report from the National Low Income Housing Coalition and the Public and Affordable Housing Research Corporation highlights the risks to the preservation of federally assisted housing, including expiring affordability



restrictions, declining physical conditions, and reduced funding. The report calls for stronger policies, including increased appropriations for federal housing programs and enhanced preservation protections, to prevent the loss of affordable homes for the lowest-income renters. Without these changes, many federally assisted homes may be lost, exacerbating housing instability.

HUD Awards \$225M To Preserve And Renovate Manufactured Homes Across 26 States

The U.S. Department of Housing and Urban Development (HUD) has awarded \$225 million to 17 groups in



26 states as part of the Preservation and Reinvestment Initiative for Community Enhancement (PRICE) program. This historic funding will preserve and revitalize manufactured housing and communities, providing essential improvements like repairs, accessibility upgrades, and resilience strategies, while promoting affordable homeownership. The program received overwhelming demand, with funds supporting low- and moderate-income residents, especially in rural, suburban, and disaster-impacted areas, and will also help transition to resident-managed communities.



HUD: Housing Programs Crucial As Homelessness Reaches New Heights

A recent report from the U.S. Department of Housing and Urban Development (HUD) reveals that homelessness reached a new high in 2024, with 771,480 people experiencing homelessness, marking an 18% increase from the previous year. While families and people of color, especially Black Americans, are disproportionately affected, the report highlights a positive trend with a decline in homelessness among veterans, which has decreased by 55% since 2009. Housing Shortages Create An Alternative To NIMBYism

to escalate in Philadelphia and nationwide, with over 770,000 people experiencing homelessness during the 2024 HUD point-in-time count, a historically high figure. In Philadelphia, homelessness has risen for the third consecutive year, driven by rising living costs, insufficient affordable housing, and untreated behavioral health issues. Local initiatives, such as adding winter beds and piloting stable housing programs, aim to address the crisis, but the demand for assistance continues to outpace resources.



The Clear, Unimplemented Solution To Homelessness

Homelessness is a complex issue rooted in systemic inequities such as racial disparities, unaffordable housing, and underfunded mental health and domestic violence resources. Instead of addressing these factors, many counties focus on punitive measures like hostile architecture and laws that criminalize the unhoused. True solutions require empathy-driven policies that prioritize affordable housing, accessible healthcare, and increased funding for preventative programs to break the cycle of poverty and homelessness.

The YIMBY (Yes In My Backyard) movement has grown from a small group in the Bay Area to a nationwide coalition advocating for increased housing development. By addressing the housing crisis with bipartisan appeal—liberals favoring affordability and conservatives seeking reduced regulation—the movement has influenced local and federal policies, promoting denser housing and challenging restrictive zoning laws. Its grassroots activism, professional advocacy, and partnerships across political ideologies have made it a powerful force against traditional NIMBY opposition.



Surviving On \$1800 A Month In Social Security, She Died Looking For A Place To Live

An older woman, facing eviction after 23 years in her apartment, struggled to navigate long waitlists and unfulfilled promises for housing assistance. Despite efforts to help, she became homeless and passed away just days before her 71st birthday, highlighting the dire challenges aging Americans face in high-cost cities, with limited resources and support.

Will The Next HUD Secretary Fight For The Unhoused?

President-elect Donald Trump nominated Scott Turner to serve as the secretary of HUD. As a lawmaker in the Texas House of Representatives, Turner opposed a bill to expand affordable rental housing. He voted against the funding for a public-private partnership to support people experiencing homelessness. The pastor turned law maker follows in the footsteps of other "compassionate conservatives" whose administrations led to the creation of homelessness as we know it today.
